- V. Discussion:
 - a. Bruce reviewed the provided a summary and reviewed the process that occurred to deliver the <u>DRAFT CRV-RPO Operating Agreement</u> and the process for ratifying the agreement. Discussion followed, the CRV-RPO Committee will vote to ratify the agreement, if that motion passes to adopt the Operating Agreement it moves to the CVDA Board for vote. - VI. Reports:
 - a. Judy and Tom presented the <u>Draft ALP for Gulkana</u>, the plans show options for short- and long-term development of the airport. Discussion followed, questions and clarification around the details of the plan, runway lengths, float pond locations lengths, final lease lots, safety, timing, process etc. A second public meeting is scheduled for Thursday 5/18, Copper Valley Air will host. All attendees from the previous meeting will receive and invite as well as public notifications on KCAM, the Local paper and on the website. The directive is to have a final ALP approved by the FAA in August.
 - b. It was brought to everyone's attention that the DNR Copper Basin Area Plan is in the public comments phase, and we should be looked at this as it relates to the airport. Judy submitted comments as to the DOT&PF's interest in the area around Dry Creek and possible airport extension, as well as airports listed as owned by BLM in the DRAFT Plan when they are actually owned by DOT&PF, this has been an ongoing dispute for certain airports that exist within the park.
